

# Privacy Policy

Dean Howarth, portraying various historic individuals under the collective title The Natural Philosopher, ("Mr. Duquette", "the Philosopher" "I", "me", "my" "us", "we", or "our") operates <http://livinghistoriesofscience.com> (the "Site"). This document informs you of my policies regarding the collection, use and disclosure of Personal Information we receive from users of the Site. It is applicable to this Site and any related site I may establish in the future.

I use your Personal Information only for providing responses to an inquiry and to provide related follow-up information. The information is forwarded from the e-mail addresses listed in the Site to me or a staff member who will be providing a detailed response.

By using the Site, you agree to the collection and use of information in accordance with this policy.

## **Information Collection and Use**

While using my Site, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you in order to respond to your requests. Personally identifiable information may include, but is not limited to your name ("Personal Information"). Typically, I only request your e-mail address and mailing address (to send you documents via the U.S. Postal Service or an overnight service such as Federal Express. Your information is **not** shared with third parties.

## **Photographic and Video Components Featuring Myself and Colleagues**

Frequently photographic and video material featuring myself and various colleagues individually and collectively is provided to us for use by third parties. As with any situation involving large groups of individuals, someone may walk into the picture just as it is being taken. Often the person taking the picture or video does not look at the result until several days later; by then it is almost impossible to locate any given individual who has wandered into the picture. At the same time, it is most likely there is no contact information for third parties in the images in order to contact them for permission to utilize the images and videos that include them.

If I have posted a picture from an appearance that includes you, and you strenuously object to an identifiable image of you appearing on the site, please contact my Site Administrator (Webmaster) using the e-mail address at the end of this document. While we can easily remove a photograph from the Sites in a short amount of time, video footage must be appropriately edited to remove a particular frame without damaging any underlying audio.

## **Log Data**

For your information, this is information that your browser may send whenever you visit my Site ("Log Data") is collected.

This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser type, browser version, the page of my Site that you visit, the time and date of your visit, the time spent on those pages and other statistics. These statistics are useful for troubleshooting search engine results by Google, Bing, Yahoo and similar services, and for the browser services to determine issues they may be having with loading certain types of pages.

## **Communications**

I use your Personal Information to contact you with information that you have requested from me. It is NOT shared with third parties.

## **Cookies**

Cookies are files with a small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a web site and stored on your computer's hard drive.

Unlike many sites, I do not use "cookies" to collect information. You can also instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of my Site due to your browser's protocols.

I DO NOT ALLOW THIRD PARTIES TO ADVERTISE OR PLACE COOKIES ON MY SITE.

## **Links to Other Sites and Resources**

I do provide links to other sites and resources, including sites belonging to my associates and friends. I also provide links to venues where I will be appearing, and to videos related to appearances that can be found on YouTube and other services of that nature. From time to time, I also provide links to resources regarding the historic persons portrayed or historic events.

If you access one of these sites, their Privacy Policies prevail while you visit. I do not control the Privacy Policies of those third party sites. Please review those carefully so you can decide if you want to continue your visit to those sites.

## **Security**

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage, is 100% secure. While I and my staff strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security. Also, we make every effort to store any Personal Information in an offline database, but ONLY if we will need it to provide future information that you have requested. We do retain e-mails we receive in order to verify that we have responded to your inquiry.

Malicious modifications to my Site by outside parties are tracked, and automatically reported to law enforcement for investigation and prosecution under applicable United States laws.
